2. Financial Disclosure Form (**SBC002**)
3. Combined Debt Schedules (by series with principal and interest as separate columns) that contains:

Outstanding Debt Secured/Payable from Same Revenue Source	Proposed Debt at Maximum Parameters
Total of Outstanding Debt	Total of Proposed and Outstanding Debt
4. Bond Production Report
5. Adopted Budget for Current Fiscal Year (*summary format*)
6. Immovable property, with a value greater than \$3,000 to be acquired, submit an appraisal (*pursuant to R.S. 33:4712.10*)
7. If Refunding, Debt to be Refunded Form (**SBC004**)

**Requirement for Ad Valorem, Sales Tax, Special Assessment, Special Tax Propositions** (*except if new tax*)

**Application Submission**

Upon completion of all required fields, select PRINT FORM button to print copies for your records.

The entire application package (application forms, certified resolution(s), financial statements, fee payment, etc.) must be received at SBC office by specified deadline, which can be found at: <https://www.treasury.la.gov/state-bond-commission>.

Electronic submissions must be sent to [SBC-Application@treasury.la.gov](mailto:SBC-Application@treasury.la.gov). Each specific document type (application form, copy of certified resolution(s), financial statements, etc.) must be included as separate attachments in pdf, Word or Excel format. For Bond elections, a scanned copy (pdf format) of the application fee check should be included as one of the attachments.

**Note:** The only originals that must be physically transmitted after electronic submission, are certified resolution(s) and application fee check, which must be received within 3 business days of electronic submission.

Upon receipt of each application submission, the documentation will be reviewed by SBC staff. A confirmation email will be sent to acknowledge receipt of the application, identify the SBC tracking number, provide the assigned analyst and confirm if minimum requirements have been met. If confirmation email is not received within 2 working days after electronic submission, call (225) 342-0040 to verify receipt of electronic submission.
